April Fundraising Committee Report

The fundraising committee met twice in the month of April. Meetings took place by telephone conference on April 4th and 27th.

After much discussion, the committee voted to cancel this year's Annual Scholarship Luncheon and postpone until September 2021 due to uncertainty over public health concerns and the economic state of the community in light of COVID-19. Any potential sponsor for the fashion show is not currently open and there is no way to know when they will be available. These leaves very little time for planning the event.

The committee recommended holding a raffle with one \$500 grand prize for the winner with tickets being \$5.00 each. Raffle ticket sales could be begin as early as June and the drawing would be held at the Holiday Party. More detail will be made available at the June chapter meeting.

The Holiday Party is still scheduled for December 19, 2020, but this, too, is pending the outcome of the COVID-19 crisis.

Fundraising Committee Recommendations:

The Fundraising Committee recommends that the Annual Scholarship Luncheon planned for September 26, 2020, at the Westmount Country Club be cancelled this year due to COVID-19. Any adjustment to the chapter assessment will be discussed at a future meeting.



The membership committee did not meet during the month of April as all major activities have ceased due to the restrictions placed on us by COVID-19. However, in order to keep sorors connected, as part of a larger chapter initiative, we have sought to meet with sorors on a weekly basis thorugh Zoom "Social Hours" designed to share, connect and engage in sisterly activities. We have hosted three successful Zoom Happy Hours summarized as follows:

	Roll call must be taken at the beginning of the meeting to establish a quorum. Once the quorum has been verified, there is no need to repeat the roll call unless for voting purposes.

required during an electronic meeting. However, the Grammateus (secretary) is not necessary as an "active participant. If you chose the "record call" feature in your application, the Grammateus' duty would be to edit the full electronic record of the proceeding after the fact and to produce a set of standard minutes. The Grammateus should also monitor the polling process for instant feedback to the Basileus.
The Technology Committee shall set up the virtual meeting room before the start time. The call-in shall be tested as well before the meeting. The Technology Committee shall assist with the controls of the meeting so that the Basileus can focus on conducting the meeting.
The various software applications provide the ability to record audio and video for the chapter records as well as a chat log. If documents are to be reviewed, these documents shall be distributed to every member before the meeting starts. The minutes of the meeting will be done in the same manner as it would be done in a physical meeting.
The recommended voting procedures during virtual meetings are determined by the Basileus who shall ensure that each person voting is accounted for via roll call, online voting, etc.
Each virtual conference platform provides an ability to see those in attendance. This feature can be utilized to expedite the establishment of a quorum. The use of chat rooms or email can assist with voting if the chapter will not be using a voting application. Where possible, accept an agenda item with consensus.

RATIONALE: Virtual meeting gives chapters an opportunity to conduct sorority business when a face to face meeting is not an option.



Reasons why people are missed by the Census Bureau...

- **Residents are hard to contact**
- ► They live in inaccessible places
- **Residents are had to interview**
- ► The have limited language proficiency
- **Residents are hard to locate**
- They are homeless or have been misplaced by a natural disaster Residents are hard to persuade
- These are people who are angry or distrust the government

Census results affect planning and funding for education-including programs such as Head Start, Pell Grants, school lunches, rural education, adult education and grants for preschool special education.
